ARTICLES OF ORGANIZATION OF JABIRU LLC

The undersigned, JAMES LEE MCDONALD III, a natural person competent to contract and an authorized representative of JABIRU LLC, hereby presents these Articles of Organization as the Articles of Organization of JABIRU LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The name and address of the initial managers of the Company is as follows:




