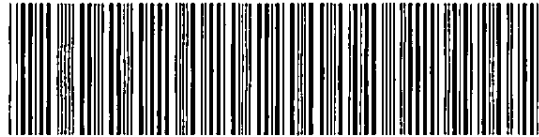

**ARTICLES OF ORGANIZATION

ARTICLE III: REGISTERED AGENT






