**ARTICLES OF ORGANIZATION
OF

ARTICLE IV – MANAGEMENT OF THE COMPANY


The Company is to be managed by one or more managers and is, therefore, a manager-managed company. The initial managers of the Company are Michael Conkle and Steven J. Umberger.


