ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (the "Act") of the State of Florida pursuant to Chapter 605 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

ARTICLE I
NAME

The name of the limited liability company shall be FOTON DISTRIBUTION, LLC (the "Company").

ARTICLE II
MAILING ADDRESS

The mailing address for the Company shall be 2525 Ponce De Leon Blvd., Ste. 250 Coral Gables, FL 33134.

ARTICLE III
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE VI STREET ADDRESS OF PRINCIPAL OFFICE

The street address of the principal office of the Company shall be located at 2525 Ponce De Leon Blvd., Ste. 250 Coral Gables, FL 33134, but it shall have the power and authority to establish branch offices at any other place or places as the Members may designate.

ARTICLE VII MEMBERSHIP RESTRICTIONS
