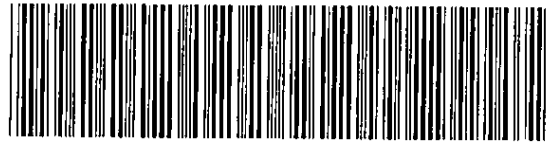

ARTICLES OF ORGANIZATION  
OF

(a Florida Limited Liability Company)

ARTICLE I

(Name and Principal Place of Business; E-mail address)
