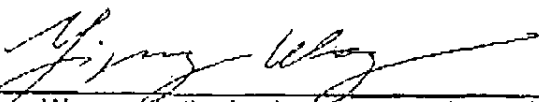
ARTICLE X - AMENDMENT OF ARTICLES OF ORGANIZATION
