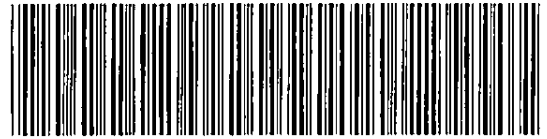

ARTICLE V. MANAGEMENT




