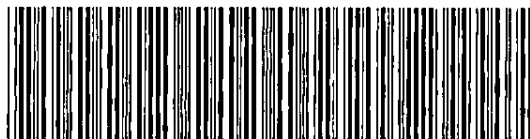

REGISTERED AGENT AND REGISTERED OFFICE**




