### ARTICLES OF ORGANIZATION OF ANTI ASSOCIATION LAWYERS, PLLC

The undersigned, for the purpose of forming a professional limited liability company under the Florida Revised Limited Liability Company Act of the State of Florida pursuant to Chapter 605 of the Florida Statutes, and the Professional Service Corporations and Limited Liability Companies Act of the State of Florida pursuant to Chapter 621 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

#### ARTICLE I NAME

The name of the professional limited liability company shall be **ANTI ASSOCIATION LAWYERS**, **PLLC** (the "Company").

### ARTICLE II MEMBERS

The Company shall have one or more members (the "Members").

### ARTICLE III MAJLING ADDRESS

The mailing address for the Company shall be 145 Almeria Avenue, Coral Gables, Florida 3313

### ARTICLE IV INITIAL REGISTERED OFFICE AND REGISTERED AGENT

#### ARTICLE V PURPOSES AND POWERS

The general nature and purposes of business to be transacted, promoted and carried on by the Company are as follows:

- B. The term and duration of the Company shall be perpetual, unless terminated in accordance with the Operating Agreement of the Company or otherwise terminated in accordance with law.

#### ARTICLE VII STREET ADDRESS OF PRINCIPAL OFFICE

The street address of the principal office of the Company shall be located at 145 Almeria Avenue, Coral Gables, Florida 33134, but it shall have the power and authority to establish branch offices at any other place or places as the Members may designate.

### ARTICLE VIII

Additional Members may be admitted to the Company in accordance with the Operating Agreement of appany. Contributions required of new Members about 1 the Company. Contributions required of new Members shall be determined as of their time of admission tothe Company in accordance with the Operating Agreement of the Company. A Member's interest in they Company shall be considered personal property, notwithstanding the actual nature of the assets owned by the Company, and may not be sold or otherwise transferred except in strict accordance with the Operating Agreement of the Company.


