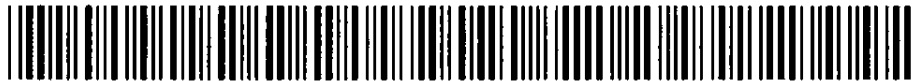


ADMISSION OF NEW MEMBERS


