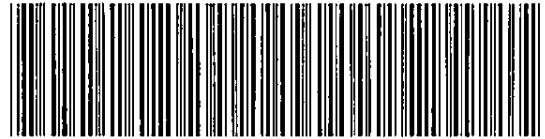

ARTICLES OF ORGANIZATION
OF
2 PALMS 2 ENTERTAINMENT, LLC

Pursuant to the Provisions of the Florida Statutes, the undersigned organizer hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I
NAME

The name of the limited liability company is **2 PALMS 2 ENTERTAINMENT, LLC** (the "Company").

ARTICLE II
DURATION

The Company shall have a duration from the date of organization until it is dissolved and its affairs wound up prior to that date in accordance with the Florida Limited Liability Company Act (the "Act").

ARTICLE III
PURPOSES

The purpose for which the Company is formed is to write, publish, and produce music, and to engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act. The Company is not to engage in any act or activity requiring any consents or approvals by law without such consent or approval being first obtained.



ADMISSION OF ADDITIONAL MEMBERS


Upon the unanimous written consent of the members, the Company may permit the admission of additional members and the terms and conditions of their admission shall be set forth in the Company's Operating Agreement.


ARTICLE VIII
