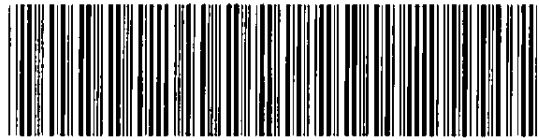

**ARTICLES OF INCORPORATION
OF**

The undersigned incorporator, for the purpose of forming a Florida not for profit corporation, hereby adopts the following articles of incorporation:

ARTICLE I - Name

The name of the Corporation is:

FAITH FIRST CHRISTIAN ACADEMY, INC.

ARTICLE II - Purpose

This corporation is organized exclusively for the purpose of contributing to the growth and development of ministries and congregations by offering services and other programs to spiritually and physically service our community and to own, manage and operate one or more private early education centers offering early learning education to students ages 6 weeks through 5th Grade.

Notwithstanding any of the statements of purposes and powers of this corporation contained herein, the corporation shall not, except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the specific purposes of this corporation.

ARTICLE V – Tax Exemption Requirements

The corporation is organized and operated exclusively for the purposes set forth in Article II herein. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements on behalf of any candidate for public office.)

ARTICLE VI - Members

The corporation shall have a membership distinct from the board of directors. The authorized number and qualifications of the members of the corporation; the manner of their admission; the different classes of membership, if any; the property, voting, and other rights and privileges of members, and their liability for dues and assessments and the method of collection thereof; shall be set forth in the bylaws. The corporation shall be nonstock and no dividends or pecuniary profits shall be declared or inure to the members. There shall be no personal liability of members for corporate obligations.



The corporation shall be subject to the bylaws of FAITH FIRST CHRISTIAN ACADEMY, INC.


