

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes. acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be BLUE NURSE PROPERTIES, LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 500 Southwest 145th Avenue Apt 341 Pembroke Pines, Florida 33027 and the mailing address shall be the same.

ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE 10 - INDEMNIFICATION

Nothing contained in these Articles of Organization shall limit or preclude the exercise of any right relating to indemnification or advance of attorney fees and expenses to any person who is or was a member; manager, employee or agent of the Company or the ability of the Company otherwise to indemnify or advance expenses to any such person by contract or in any other manner.
