The undersigned, David Andes, a natural person competent to contract and an authorized representative of 30A Spotless Solutions, LLC, hereby presents these Articles of Organization as the Articles of Organization of 30A Spotless Solutions, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME
