TO
ARTICLES OF ORGANIZATION OF

THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF **GOTTHELF BREEZE ONE LIMITED LIABILITY COMPANY**, a Florida limited liability company (the "Company"), are executed by the undersigned Authorized Representative of the Company for the purposes set forth herein:

1. The name of the limited liability company is GOTTHELF BREEZE ONE LIMITED LIABILITY COMPANY.
2. The Articles of Organization were filed on August 29, 2024, and assigned document number L24000480702
3. The Company has approved to make the following change to the Articles of Organization: changing the name of the Company from GOTTHELF BREEZE ONE LIMITED LIABILITY COMPANY to **GOTTHELF BREEZE ONE LLC**.


4. The Company has adopted the following amendment to the Articles of Organization:

Article I is hereby amended and restated in its entirety to read as follows:

ARTICLE I - NAME

The name of the limited liability company is **GOTTHELF BREEZE ONE LLC**. This limited liability company is referred to in these Articles of Organization as the "Company."
