ARTICLES OF ORGANIZATION

OF

BLACK BIRD RANCH EQUIPMENT, LLC

The undersigned, acting as the organizer of BLACK BIRD RANCH EQUIPMENT, LLC under the Florida Revised Limited Liability Company Act, Chapter 605. Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME:
