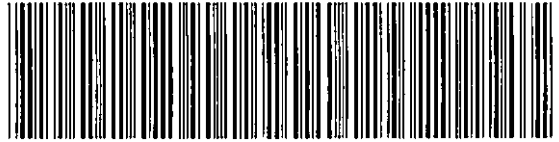

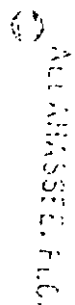

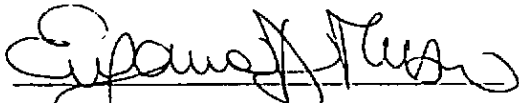
**ARTICLE V: DURATION**
