1. I am the duly authorized representative and President of **The Constitutionalists, Inc.**, a corporation that was previously registered with the Florida Division of Corporations on **January 18, 2022**, under **Document Number N22000000820**.
2. **The Constitutionalists, Inc.** was administratively dissolved on **September 22, 2023**, and no action has been or will be taken to reinstate the corporation to active status.
