ARTICLE IV – REGISTERED OFFICE AND AGENT

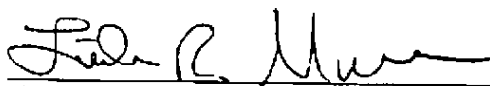
