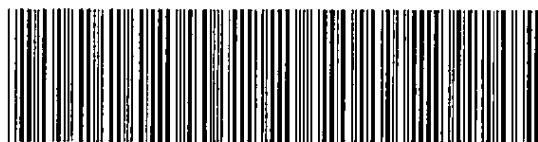

ARTICLES OF ORGANIZATION

OF

ARTICLE X - AMENDMENT

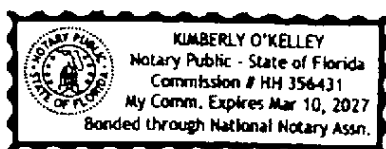



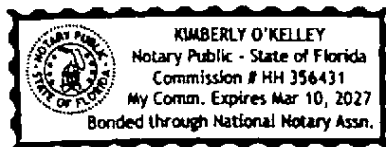
