**ARTICLES OF ORGANIZATION
OF

(A Limited Liability Company)

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, hereby adopt the following Articles of Organization:

ARTICLE I

The business of the company shall be managed by a manager who shall have such powers and authority as are set forth in the operating agreement of the company. The Manager shall be:




