ARTICLE III.

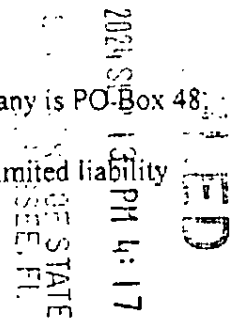

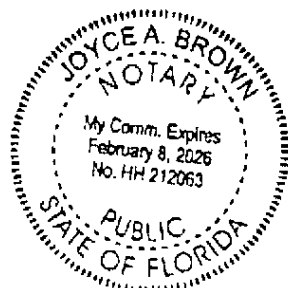
