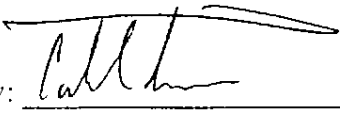

FURTHER RESOLVED, the management of the Company is reserved to its Manager. The initial Manager of the Company is Caleb Turner; and

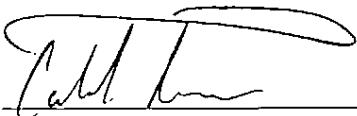
