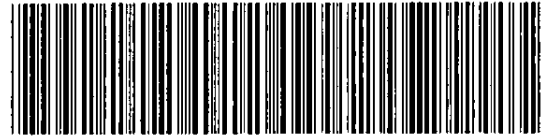

1. Name: The name of the limited liability company is EZLend LLC.
2. Filing: The Articles of Organization of the limited liability company (the "Articles of Organization") were filed on September 20, 2024, and were assigned Document Number L24000406402.
3. Amendment: The following amendments to the Articles of Organization was adopted by the limited liability company.

Article I of the Articles of Organization is deleted in its entirety and replaced with:

"ARTICLE I

The name of the Company shall be Vivo Finance LLC."

Article II of the Articles of Organization is deleted in its entirety and replaced with:

"ARTICLE II: ADDRESS AND PLACE OF BUSINESS
