**ARTICLES OF ORGANIZATION  
OF  
SRTJR MINING TERRACE, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**Article 1 — Name**

The name of this limited liability company is SRTJR Mining Terrace, LLC (the "Company").

**Article 2 — Duration**
