The name and street address of the initial registered agent of the Company are Jay Chaudhari, 154 South Park Avenue, Suite 201 Winter Park, Florida 32789.

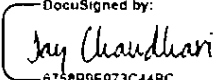
ARTICLE V. MANAGEMENT
