**ARTICLES OF ORGANIZATION**

DownsAaron PLLC (the "Company") filed its original Articles of Organization with the Florida Department of State on September 23, 2024 (the "Original Articles") and was assigned document number L23000410084. These Amended and Restated Articles of Organization were duly adopted by the Company and were prepared in accordance with Section 605.0202, *Florida Statutes*.

**ARTICLE I**  
**Name**

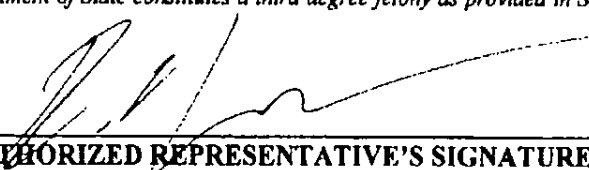
