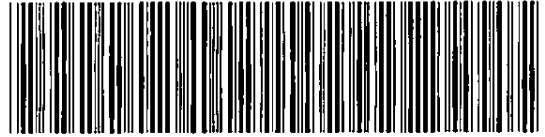

NAME

ARTICLE IX




