The undersigned, Harvey Lee Strayhan III, a natural person competent to contract and an authorized representative of Strayhan & Strayhan, PLLC, hereby presents these Articles of Organization as the Articles of Organization of Strayhan & Strayhan, PLLC, a professional limited liability company formed under the provisions of Chapter 605 and Chapter 621, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the professional limited liability company is Strayhan & Strayhan, PLLC. This professional limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**


