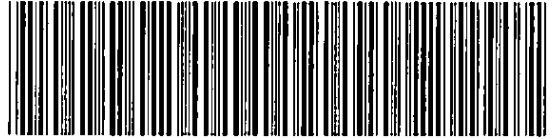

**ABILLIFEYE, INC.**, a Florida corporation, Document Number P23000047116



