**ARTICLES OF ORGANIZATION

Thorne, a natural person competent to contract and an authorized representative of a member of My Dream World, LLC, hereby presents these Articles of Organization as the Articles of Organization of My Dream World, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

## ARTICLE I - NAME

The name of the limited liability company is My Dream World, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

## **ARTICLE II - PRINCIPAL OFFICE ADDRESS**
