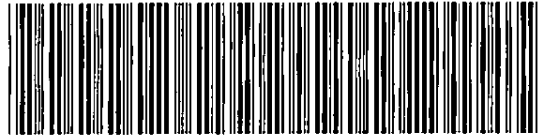

In addition, as instructed by the letter from the Division of Corporations, we have also attached a copy of that original letter.

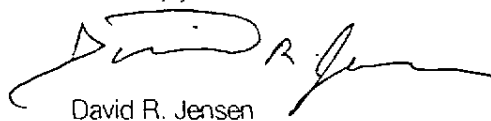

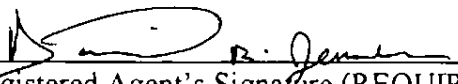

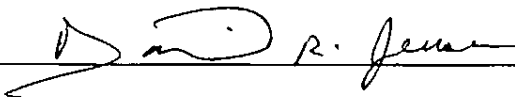
