The undersigned, Greg Cook, a natural person competent to contract and an authorized representative of a member of CAMJK Design LLC, hereby presents these Articles of Organization as the Articles of Organization of CAMJK Design LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is CAMJK Design LLC. This limited liability company is referred to in these Articles of Organization as the "Company."




