ARTICLES OF ORGANIZATION
of
BOWIE INVESTMENTS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "Act"), hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I
NAME AND ADDRESS

The name of the limited liability company shall be Bowie Investments, LLC (the "Company"). The mailing address of the Company shall be P.O. Box 215, Orange Park, Florida 32067. The street address of the principal office of the Company shall be 1848 Park Avenue, Orange Park, Florida 32073.

ARTICLE II
PURPOSES AND POWERS

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved pursuant to the terms of the Company's
