The mailing address and the street address of this Company shall be 375 Atlantic Boulevard, Atlantic Beach, Florida 32233.

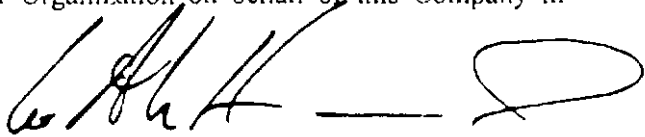

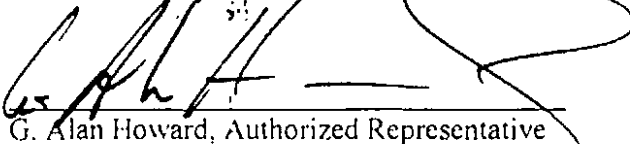
