**ARTICLES OF ORGANIZATION**  
*of*

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "Act"), hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be KY 882 Dawson Springs, LLC (the "Company"). The mailing and street address of the principal office of the Company shall be 5465 Verna Boulevard, Jacksonville, Florida 32205.

**ARTICLE II**

**PURPOSES AND POWERS**

The Company shall be terminated and dissolved pursuant to the terms of the Company's operating agreement, which may be amended from time to time, or in the absence of an operating agreement, by the Act.




