ARTICLES OF ORGANIZATION

OF

FLORIDA SPINE INJURY CLINIC, PLLC

Pursuant to (i) the Florida Limited Liability Company Act, Chap. 605, Florida Statutes, and (ii) the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes (collectively the "Acts"), the following are adopted as the Articles of Organization of the professional limited liability company organized hereby:

ARTICLE I - NAME

From: The name of the professional limited liability company (the "Company") shall be Florida Spine Injury Clinic, PLLC.

ARTICLE II - ADDRESS

The mailing address and the street address of the principal office of the Company shall be 7807 Baymeadows Road East, Suite 208, Jacksonville, Florida 32256.

ARTICLE III - REGISTERED AGENT


