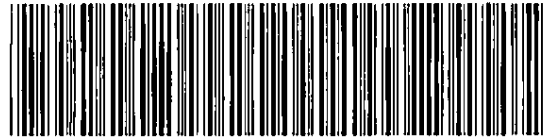

The name of the Limited Liability Company is: **Arviv Family LLC** (the "**Company**").


