

ARTICLES OF ORGANIZATION OF BARBER ACADEMY, LLC

The undersigned, acting as the organizer of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), hereby forms a Florida limited liability company (this "Company") pursuant to the Act and hereby sets forth the following Articles of Organization (these "Articles"):

ARTICLE I Name

The name of this Company shall be: BARBER ACADEMY, LLC

The principal place of business and mailing address of this Company shall be 1426 Harbour Walk Road, Tampa, Florida 33602, and such other place or places as may be designated by the manager from time to time.

ARTICLE III Registered Agent and Office

The initial registered agent for this Company shall be CHESTNUT BUSINESS SERVICES, LLC and the address of the registered agent for service of process shall be 311 Park Place Boulevard, Suite 300, Clearwater, Florida 33759.

ARTICLE IV Membership Units

This Company shall be authorized to issue One Million (1,000,000) membership interests, no par value, which shall be divided into two (2) classes: (i) 250,000 Class A Voting Membership Units, which shall be designated as "Voting Units," and (ii) 750,000 Class B Non-Voting Membership Units, which shall be designated as "Non-Voting Units." Each of the Voting Units shall entitle the holder thereof to one (1) vote at any meeting of the members. There shall be no other differences in the rights of such membership units.

ARTICLE V : 15: Management of Business

The Company shall be manager-managed. The initial manager of the Company shall be JONATHAN ASCENSAO, whose mailing address is 4612 Netherwood Drive, Tampa, Florida 33627.
