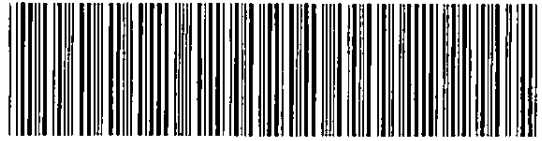

MANAGEMENT**


