ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is **COOPER FINANCIAL HOLDINGS, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The mailing and street address of the Company's principal office is **2400 S. McCall Rd., Suite C, Englewood, Florida 34224.**

4. Management of the Company. The management of the Company shall be vested in the manager of the Company. The name and address of the initial manager of the Company is as follows:


