**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is High Tidings 1, LLC, a Florida limited liability company (the "Company").
2. Duration and Effective Date. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.

9. Voting. The Company is authorized to issue membership interests with voting rights and membership interests without voting rights.


10. Certificated Interests. The member's interest in the Company may but need not be evidenced by certificates.
