### ARTICLE I <u>NAME; APPLIC</u>ABLE LAW

The name of the limited liability company formed pursuant to the filing of these Articles of Organization (the "Articles") is "GOSHEN HAVEN LLC" (the "Company"). # ARTICLE VI RESTRICTIONS ON TRANSFER; ADMISSION OF ADDITIONAL OR SUBSTITUTE MEMBERS
