ARTICLES OF ORGANIZATION
of
TITAN REAL ESTATE PARTNERS LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "*Act*"), hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Titan Real Estate Partners LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 919 NW 57th Street, Suite 20, Gainesville, Florida 32605.

ARTICLE II

PURPOSES AND POWERS

The Company shall be terminated and dissolved pursuant to the terms of the Company's operating agreement, which may be amended from time to time, or in the absence of an operating agreement, by the Act.
