ARTICLES OF ORGANIZATION

FOR

The undersigned, as the organizing Member of a Limited Liability Company to be formed under the Florida Revised Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

ARTICLE I Name

The Name of the Company is ReBuild Home Renovations, LLC, a Florida limited liability company.

ARTICLE II Commencement Date and Duration

The Company's existence shall commence on filing these Articles with the Florida Secretary of State, and shall continue perpetually unless dissolved in accordance with Section 605.0701 of the Act.

ARTICLE III Purpose

The Company is created to conduct any lawful business under the laws of the State of Florida.

ARTICLE VII Powers

The Company shall have all of the powers and authority set forth in Section 605.0109 of the Act unless limited by these Articles of Organization or the Operating Agreement.

ARTICLE VIII

Membe<u>rs</u>

The Company will have two classes of membership designated Class A and Class B. The rights and obligations of each class of Members will be set forth in the Operating Agreement.

ARTICLE IX Property

- (a) Ownership. All funds paid to the Company as contributions to capital by the Members, and all property acquired by the Company by purchase or otherwise, shall be the property of the Company.
- (b) <u>Title.</u> The title to all property of the Company shall be held in the name of the Company.

ARTICLE IX Amendments

These Articles may be amended or restated at any time by the unanimous vote or consent of the Class A Members, and such amendment or restatement shall be filed with the Florida Department of State in accordance with the provisions of Section 605.0206 of the Act.

ARTICLE X Operating Agreement

An Operating Agreement shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Operating Agreement may conflict with the provisions of these Articles unless permitted herein. The power to adopt, alter, amend, or repeal the Operating Agreement shall be set forth therein.

ARTICLE XI Contracting Debts

No debt shall be contracted nor liability incurred by or on behalf of the Company except by a Manager of the Company as provided in the Operating Agreement, and no Member is authorized or empowered to contract debts or incur liabilities on behalf of the Company unless such Member is also a Manager.
