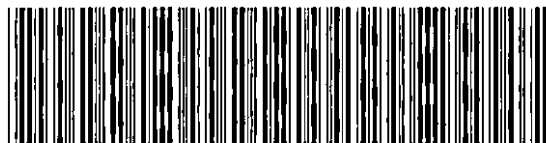

**ARTICLES OF ORGANIZATION
OF

The mailing address and street address of the principal office of the Company shall be 2646 Miller Court, Weston, Florida 33332.


ARTICLE III. REGISTERED AGENT AND OFFICE
