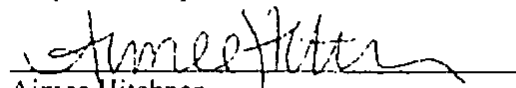

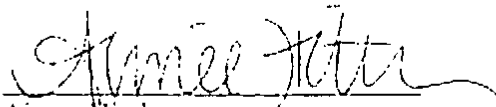
9. Continuity
