ARTICLES OF ORGANIZATION OF ST. PETE STRONG, LLC

- 1. Name. The name of this limited liability company is ST. PETE STRONG, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
- 2. <u>Place of Principal Office.</u> The physical address and mailing address of the Company is 435 5th Avenue N., Suite 200, St. Petersburg, Florida 33701.

- 5. <u>Duration.</u> The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- 6. <u>Purpose: Operating Agreement.</u> The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
