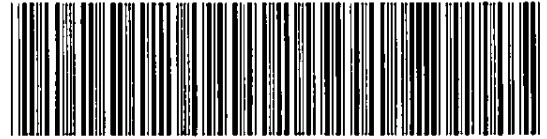

The name of the limited liability company is HALLYS INVESTMENTS LLC (the "Company").


ARTICLE II. MAILING AND STREET ADDRESS
