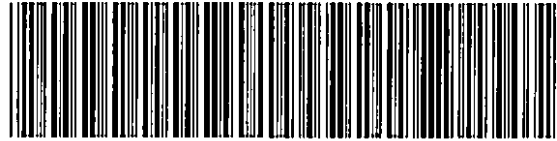

5. The plan of conversion has been approved in accordance with all applicable statutes.






